a. Petitioner Comments

Joe Vavrina HR Green and Melanie Soos of Soos Associates addressed the Commission with an updated presentation.

Site Plan dated December 21, 2018 has little changes to the plan only changes for IDOT for the requirement of the right lane deceleration of speed from Rand Road.

No stormwater holding tanks for stormwater and all stormwater will drain into dry ponds. Commission requested elevations to show grade changes on the site. Commission discussed the drainage of water from the car wash exit. Melanie Soos stated all water will drain away from the building and into the retention ponds.

Wall sconces have been updated on the cut sheet for the car wash and convenient store scones size of the light can change to complement size of structure.

Commission discussed the window on the southeast side above the ice machine could be raised 6 to 8 inches due to the height of the ice machine. Melanie Soos stated the window is

blacked out and really didn't matter. Commission stated the window could be addressed at permitting.

Updated site Plans - West elevation renderings show old bollard placing. Petitioner is to provide update site plans with either; No Curbs & bollards or Curb & no bollards

Sidewalk termination – Either complete sidewalk to Plum Grove Road or provide cost to do so and amount will be placed in escrow for future installation

Native Vegetation Maintenance Plan - to specify low-profile seed mix

Landscape Plan – Replace the Blue Speedwell adjacent to sidewalk on Rand Road with Gro-Low Sumac.

L-03 updated to include "planting mix" details

Irrigation - Indicate overspray minimization

Architecture – Outdoor patio specs will be submitted to the Village for approval prior to install.

Commission discussed the level of lumens is 3.86, this is normal for a gas station.

Village Building & Zoning Official Garrett, B&F letter dated December 19, 2018 Irrigation Drawings to indicate

Plumbing installed shall be in compliance with the 2014 Illinois plumbing Code Sprinkler locations to be located on private property

Water source for irrigation must be from well and shall not be from a potable water supply. Discussion of which aquafer Circle K will be allowed to tap into, this will be address at permitting.

Discussion of used water from car wash. Water is contained, filtered and reused.

Rain water will be directed to retention ponds from the site.

Discussion of the pricing from both stores, Phil Bolduc from Circle K stated both stores are going to be corporate owned and the pricing will be the same at each location.

Long Grove Fire Protection, Fire Inspector Lovelady Discussion of Water flow test for Fire Hydrants and Fire Sprinkler evaluation
