

**Consolidated Election, April 1, 2025**  
**The following positions will be available within the Village of Deer Park, IL,  
Lake & Cook Counties for the April 1, 2025, Consolidated Election:**

One (1) President – Full, Four-Year Term  
Three (3) Trustees – Full, Four-Year Term

If you are looking for a way to be more involved in your community, consider running for Village President or Village Trustee. There are three steps to follow in order to allow your name on the ballot and run for President or Trustee as an Independent candidate:

1) Pick up a candidate petition packet at the Village of Deer Park Hall during normal business hours or download packet from the Village website at <https://www.villageofdeerpark.com/DocumentCenter/View/2209/Deer-Park-Courtesy---Independent-Packet-for-Consolidated-Election---April-1-2025?bidId=>

*Village Hall Business Hours are 8:00 am – 4:00 pm, Monday through Friday.*

Fill out the necessary forms including:

2) Circulate your petition for candidacy. A candidate running for Village President or Village Trustee for Deer Park needs a minimum of 32 signatures from registered voters living in the Village of Deer Park and not more than 82. Be sure to adhere to state law regarding the first day to circulate petitions which is August 20, 2024, for candidates seeking election in the 2025 Consolidated Election.

3) Candidates must file their petition packet with the Village of Deer Park Clerk during the filing period. The first day to file petitions is **Tuesday, November 12, 2024, from 8:00 am to 4:00 pm** and the last day to file petitions at the Deer Park Village Hall is **Monday, November 18, 2024, from 8:00 am to 5:00 pm**. Candidate names will be placed on the ballot in the order in which the qualified petitions have been filed. However, if there are simultaneous filings at 8:00 a.m. on the first day (including any petitions received in the first mail of that day and for those waiting in line at 8:00 a.m.), a lottery will be held to determine which filer is named on the election ballot first. For any petitions filed between 4:00 and 5:00 p.m. on the last day, a lottery will be held to determine which filer is named on the election ballot last. Any lottery will be held on November 19, 2024, at 10:00 a.m. at Deer Park Village Hall in the Conference Room at 23680 W. Cuba Rd., Deer Park, IL 60010. Please note the Village Office Staff will not notarize any of these documents.

The last day for filing objections to any candidate petition is Monday, November 25, 2024, by 4:00 p.m.
